1. The Bidders can inspect the material during office hours lying in the PPV&FRA, S-2 NASC, between 10.00 AM to 5.00 PM during 18.09.2015 to 11.10.2015.
2. Tender forms are available on our website www.plantauthority.gov.in and downloaded forms may be used.
3. EMD will be Rs. 2000/- (Two Thousand Only). EMD, in Indian Rupees by way of account payee demand draft drawn in favour of the "Registrar, PPV&FRA" payable at New Delhi, is to be attached with each auction bid.
 - a) The bids as per Annexure-I should be signed by bidder/himself/ themselves or a person duly authorized.
 - b) Overwriting or alternations will disqualify the bid unless these are legible attested by bidder/ bidders.
4. The sealed auction bids should be dropped in the tender box available on the PPV&FRA, S 2 Block NASC Complex DPS Marg, Opposite Todapur Village, New Delhi-110012 super-scribed with the words "Quotation for junk item".
5. The auction bids not fulfilling the norms specified herein will be summarily rejected without assigning any further reasons.
6. Auction bids received after the due date will be rejected.
7. The sealed auction bids will be opened on 12.10.2015 at 02.30 PM in the presence of bidders or their authorized representatives present at the time in PPV&FRA Committee Room, New Delhi. In case the above date will be a holiday or inconvenient for other reasons it will be carried out to the next working day.
8. Bids found unsigned by the bidders or incomplete for other reasons are liable to be rejected.
9. During opening of auction bids, only the person who has signed the application will be allowed to participate. The signatory may authorize his official with proper authorization letter no. mobile phone no. Then he will be permitted during the opening of the auction bid.
10. The auction bids received up to the date and time scheduled will be opened by the tender committee.
11. The EMDs of all the bidders will be retained until confirmation of the successful bid and the same will be released only after the confirmation.
12. The successful buyer has to pay 25% on the spot and shall pay the remaining bid amount within 5 days of the opening of quotation. All payments are to be made in Indian rupees in the form of account payee demand draft drawn in favour of the Registrar, PPV&FRA.
13. As soon as the full amount of the bid money is paid by the successful buyer, he shall acquire lien on the auctioned material and its safety from any damage or pilferage, fire, or any other

unforeseen calamity will be his duty/ responsibility and no claim whatsoever on this account shall be entertained.

14. The buyer shall remove the item within 15 days from the date of confirmation.
15. Once the successful auction bid is awarded by the office, he will be solely responsible for the dismantle of item auctioned; loading/ unloading and transportation of entire lot item. The office will not bear any cost towards this or otherwise.
16. Any damage to the Authority property during the shifting or removing of the item will be charged from the bidder.
