The quotation should reach PPV&FR Authority latest by 9:00 A.M to 3:30 P.M on 15.06.2018. The quotation received in time will be opened at 3:30 P.M on 18.06.2018. The cover should be prominently superscripted with the words "QUOTATION FOR PURCHASE OF OLD VEHICLE". The vehicle will be available for inspection between 01.06.2018 to 07.06.2018 at 11:00 A.M to 3:00 PM on all working day.

The quotation will be opened in the Committee Room of PPV&FR Authority, NASC Complex opp. Todapur Village, New Delhi- 110012. The bidders or their representatives (not more than one for each quotation) may be present, if they so desire, at the time of opening of quotation.

The sale will be governed by the following conditions: -

- I. The bidders are required to pay Earnest Money of Rs. 2,000.00 (Rupees Two thousand only) for the vehicle.
- II. Earnest Money is payable by means of Demand Draft drawn in favour of PPV&FR Authority, New Delhi, (payment by cheque or cash shall not be accepted)
- III. Quotation received without demand draft towards Earnest Money will not be considered and shall not be accepted.

- IV. The successful bidder will be required to deposit the bid amount by mean of Demand Draft drawn in favour of PPV&FR Authority, New Delhi within three working days of the acceptance of the bid.
- V. The Earnest Money of the successful bidder will be released only after the bidder deposits the sale proceeds. Earnest Money will not be adjusted as sale proceeds and will be forfeited if he fails to honour the bid.
- VI. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Voter Identity Card / Aadhar Card in case of individual and Registration Certificate in case of firms etc.)
- VII. The sold vehicle will be removed by the successful bidder within 48 hrs. of depositing the money, at their own expenses.
- VIII. The vehicle will be disposed of on "as is where is basis" and no guarantee for its worthiness or quality will be given by the Authority.
- IX. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
